

# Registration Guideline

## ACCTCS 2025

1. Once you receive the **Notification of Acceptance** from ACCTCS 2025 Organization Committee, you are required to finish the registration process within **2 weeks**. Otherwise, the submission of your paper will be regarded as a new paper to repeat the review process once again.

### a. Final paper

According to the IEEE publication policies, all papers submitted need to meet the standard format requirement. Please read the **Word Template** carefully, and then modify the format of your full paper ensuring that the front, front size, spacing, title, etc., meet the standard format of IEEE.

The final paper in word after the modification is one the key documents you should send to us during registration. So please make sure you make it the right way.
